MAS and thus ensure that in all dealings with clients or prospective employees or workers for other customers is and will remain neutral. To ensure the integrity and preservation of both can be demonstrated was established following the principals.

- MAS Exports, certificates only after review by a certified competent and independent member of the management team (who was not involved in the review process) to make sure that no interest shall prevail.
 - •MAS, does not provide (and never offered) consulting management system, or any other form of consulting companies or individuals.
 - •MAS, does not provide (and never offered) internal audit of its customers are supported service.
 - •MAS does not own or have any interest (financial or otherwise) in any other company that offers certificate or advisory services management system.
 - ,•MAS does not have (and will not form) any relationships with companies that provide consulting or other services that can be interpreted as an effect on the certification services provided by the MAS, any proposed relationship between the MAS,. And any other company will be subject to a risk assessment by the Integrity Committee before they can be officially relationship. Any existing relationships with companies, organizations and individuals will be risks on a regular basis of an evaluation to ensure that the relationship does not affect the integrity of the proceedings of ratification.
 - •Individuals employed by or otherwise contracted to MAS, there is a need to document and record the current and previous relationships with all companies. Required of any past or present situation, which may pose a potential conflict of interest through the MAS to be announced.
 - •MAS information will be used to identify any threats to the integrity of the individual will not be used in any capacity unless they can prove that there is no conflict of interest.

MAS, requires organizations and our customers-:

- A. be in conformity with the requirements of the certification body when referring to the case of a degree in communications media such as the Internet, brochures or advertising, or other documents.
 - B. Do not make any statement or misleading statement about the adoption.
- C. Do not use or allow the use of the instrument of ratification or any part thereof misleading manner.
- D. when the suspension or withdrawal of its adoption, be used for all advertising material that contains a reference to the ratification stop.
 - E. amend all advertising material when it was reducing the scope of certification.
- F. Do not allow reference to the management system certification to be used in such a way means that the certification authority attests product (including service) or procedure.
- G. does not mean that the certification applies to activities that are outside the scope of certification.
- H. Do not use adopted in such a way that would bring the certification body and / or certification system into disrepute and lose public confidence
